Petitioners are Casual Labour Roll (CLR) Peon workers under the Calicut University. They were not called for the interview for selection to appoint as Peon/Watchman. It is admitted now that based on the interim orders, they were permitted to interview provisionally. In the light of the interim orders, I am of the view that nothing further survives in this writ petition, the interim orders are made absolute and declare that the petitioners are entitled to be considered for selection to 30% cadre strength of Peon/Watchman from the CLR employees for the purpose of appointment as Peon and Watchman.
