JUDGMENT

In the light of the ratio laid down in **Shajahan M.I. v. Alice George and Ors.** [2015 (1) KHC 811], the present writ petition is also disposed of on the same lines, applying the ratio laid down by the learned single Bench in the said decision, thereby quashing Exhibit P5.
