JUDGMENT

The petitioner asserts that she did submit Ext.P4 application with the fourth respondent. This was at a time when Ext.P3 One Time Settlement scheme was in vogue. I permit the petitioner to submit a supplemental representation to the fourth respondent in continuation of Ext.P2 application.

2. Any such application filed within three weeks from today shall be dealt with within three weeks therefrom. The possibility of extending the benefit of Ext.P3 One Time Settlement scheme to the petitioner shall be explored. The recovery proceedings pursuant to Ext.P7 notice shall be put on hold in the meanwhile.

3. The petitioner will lose the benefit of this judgment if a supplemental representation is not filed within the time specified.
