J U D G M E N T

The petitioner is aggrieved with the non-consideration of Ext.P4 representation for mutation and for acceptance of basic tax. An application was in fact, earlier filed, which has not been considered, upon which, the above representation has been filed.

2. The learned Government Pleader submits that there is some dispute with respect to the exemption claimed on the basis of the nature of the property which is said to be plantation.

The learned Government Pleader submits that some time may be granted for verification of the same and considering the application. In such circumstance, the 2nd respondent shall consider the same and pass written orders, in accordance with law, within a period of three months from the date of receipt of a certified copy of this judgment.
