JUDGMENT

Shaffique, J.

The petitioner has approached this Court seeking police protection alleging that respondents 6 to 12 are threatening and conducting demonstrations, picketing etc in front of his house. An interim order had already been passed by this Court on 22.04.2014 by which the Police was directed to maintain law and order.

2. Learned counsel for the petitioner submits that the petitioner apprehends such threats again from respondents 6 to 12. Learned counsel appearing for respondent Nos.6, 11 and 12 submits that they have already approached the Legal Services Authority and an award has already been passed against the Society and they are only proceeding to execute the award passed.

3. Having regard to the aforesaid submission we do not think that any further directions are required to be passed

in this petition. However, we only observe that if there is any threat by which the party respondents may either obstruct or make agitation at the residence of the petitioner, on the complaint of the petitioner, Police shall look into the same and do the needful in accordance with law.

With the above observation, the Writ Petition is disposed of.
