JUDGMENT

Petitioner approached the Managing Committee of Guruvayoor Devaswom Board claiming promotion as Clerk from the feeder category of Room Boy. Petitioner submits that in the light of Exts.P6 and P7 Government orders, he is entitled for promotion as a Clerk.

2. Learned Standing Counsel opposed the prayer of the Writ Petitioner and submits that Exts.P6 and P7 had not been adopted by the Board for the purpose of implementation in Guruvayoor Devaswom.

3. In the light of the above, I am of the view, since Ext.P9 is pending before the Managing Committee, appropriate decision shall be taken on Ext.P9 after affording an opportunity of hearing to the petitioner within a period of two months from the date of receipt of a copy of this judgment.

The Writ Petition is disposed of. No costs.
