J U D G M E N T

The petitioner had filed an application for regular permit in the route Cherplassery - Karingalathani through a newly constructed bridge. However, the same was rejected for reason of objectionable scheme violation of 4 kms. between Shornur and Kulappully by Ext.P6. The petitioner has now filed a modified application avoiding that sector. The regular permit application filed by the petitioner is Ext.P7 and the temporary permit application is Ext.P8. Both on the modified route. In such circumstance, within three weeks from the date of receipt of the certified copy of this judgment, the temporary permit application shall be considered after hearing the K.S.R.T.C also.

The writ petition is disposed of.
