J U D G M E N T

The petitioner claims an education loan on the basis of the examination conducted by one Viswa Sai College of Nursing, Bangalore.

2. Admittedly, the same is not based on a common entrance examination conducted by the Government/Universities. Ext.P1 certificate, issued by the College, itself indicates the admission to be under the management quota. The petitioner does not have the minimum required marks as per the scheme. Exts.P2 and P3 have been modified by the Indian Banks' Association.

3. This Court has found against the grant of educational loan to management seat students, by judgment in W.P.(C) No.11421 of 2015 and connected cases dated 17.07.2015, if they don't satisfy the minimum required marks. The same would govern the above writ petition also.

The writ petition would stand dismissed.
