JUDGMENT

The petitioner claims an education loan on the basis of the examination conducted by one Spurthy College of Nursing, Bangalore. Admittedly, the same is not based on a common entrance examination conducted by the Government/Universities. In such circumstance, the same can only be presumed to be one under the management quota under the College. The petitioner does not have the minimum required marks as per the scheme. Exts.P1 to P3 have been modified by the Indian Banks' Association.

This Court has found against the grant of educational loan to management seat students by judgment in WP(C) No.11421 of 2015 and connected cases dated 17.07.2015. The same would govern the above writ petition also.

The writ petition would stand dismissed.
