JUDGMENT

The petitioner is unable to make a lump sum payment and avail the benefit of 'Ashwas-2015' scheme. All that the petitioner prays is for easy instalments to pay the amount due which comes to about ₹ 3,20,999/-.

2. I permit the petitioner to pay the amount due in eight equal monthly instalments starting from 30.05.2015. The coercive steps pursuant to Ext.P1 notice shall be put on hold if the petitioner complies with the conditions in time. The coercive steps shall surge ahead if the petitioner commits default in the payment of any one of the instalments as directed.
