The petitioner was appointed as UPSA at BEM Upper Primary School, Feroke. Her proposal of appointment has been rejected by Ext.P2. The manager moved before the Director of Public Instruction by Ext.P4 to take up the appeal by condoning the delay. The petitioner approached the Government by Ext.P5. I am of the view that appropriate decision shall be taken by the Government, after hearing the petitioner and the manager within a period of four months. In view of the above direction, the Director of Public Instruction shall drop all further proceedings pursuant to Ext.P4.
