J U D G M E N T

Being aggrieved of Ext.P9 order passed by the 2nd respondent the petitioner has moved the 1st respondent by filing Ext.P10. Prayer is to cause the same to be considered and disposed of within a reasonable time.

3. Considering the limited extent of relief sought for, this Court does not find it necessary to go into the merits of the case or to issue notice to the 4th respondent. The writ petition is disposed of, directing the 1st respondent to consider and pass appropriate orders on Ext.P10.
