JUDGMENT

The issue pertains to the recruitment to the post of Data Entry Operator in the petitioner bank. The matter involves many factual adjudication for which the writ jurisdiction is inappropriate. The petitioner is free to challenge Ext. P11 order in statutory appeal with the Government. An appeal lies under Section 83(1)(j) of the Kerala Co-operative Societies Act, 1969.

The writ petition is dismissed without prejudice to the above.
