J U D G M E N T

The petitioner is aggrieved by the proceedings taken against the petitioner's property for settlement of dues in respect of Certificate No.KR/KNR/18015/Enf.I(1)Sp.RRC/2014-15.

2. Considering the confined prayer made for instalments, it is directed that no sale shall be proceeded on condition of the petitioner settling the entire dues in twelve equal monthly instalments. The 1<sup>st</sup> instalment shall be paid on or before 08.05.2015 and thereafter; the due date of instalments falling on the 08<sup>th</sup> of each succeeding month. If default is committed in two consecutive instalments, then the recovery proceedings shall revive and continue.

The writ petition stands disposed of as above. No costs.
