Ext.P5 bill refers to the final order dated 3.3.2015 issued under Section 126 of the Electricity Act. The petitioner is free to obtain a copy of the said order from the second respondent for the purpose of appeal. A newly constituted appellate authority functions pursuant to the judgment in Muhammed Haji v. Kerala State Electricity Board [2014 (3) KLT 706].

2. The petitioner is free to file an appeal in terms of Section 127 of the Electricity Act. Needless to say that the appeal has to be accompanied by the statutory deposit which is mandatory. The electricity connection shall be restored to the petitioner on his filing an appeal with the statutory deposit. The electricity connection shall be restored after ensuring that the unauthorised extension is snapped.

The Writ Petition is disposed of.
