JUDGMENT

The petitioner applied for a regular permit for Thalassery - Kuthuparamba route, which passes through rural and ill served areas. As the regular permit is pending consideration, in the meanwhile the petitioner applied for a temporary permit. It is only appropriate that Ext.P2 application for the temporary permit be considered and orders passed thereon, especially when the regular permit application is pending consideration.
