This writ petition has been filed alleging harassment by police. It is submitted that the petitioners have contracted marriage as per Marriage Certificate dated 6.4.2015. However, the 3rd respondent, at the instance of the 4th respondent, has called upon the 2nd petitioner to the police station and harassing him. Apprehending that he will be harassed by the police, this writ petition has been filed.

2. Learned Government Pleader on instructions would submit that on the complaint by the girl's mother, the police had called the 2nd petitioner. He was only asked to appear before the Magistrate to give necessary statement.

3. Having regard to the aforesaid factual situation, we do not find any harassment as alleged by the petitioners. The 2nd petitioner was called only on account of the complaint

received by the police. It shall be open for the 2nd petitioner to appear before the Magistrate and give necessary statement.
