JUDGMENT

The petitioner seeks regularisation in service as Conductor. The petitioner asserts that he has to put in more than ten years of service in the Kerala State Road Transport Corporation. The absence of the attendance book in the depot shall not work to the prejudice of the petitioner. The petitioner has in this regard submitted Ext.P12 representation with the first respondent.

2. I direct the first respondent to consider Ext.P12 representation with notice to the petitioner. The petitioner is free to produce the necessary documents in support of his claim. Final orders shall be passed within a period of two months from the date of production of a copy of this judgment.
