JUDGMENT

Petitioner's vehicle - Tipper Lorry - has been seized. Petitioner's case is that the vehicle has been seized alleging violation of the provisions of the Mines and Minerals (Development and Regulation) Act, 1957. He seeks to compound the offence under Rule 111 of the Kerala Minor Mineral Concession Rules, 1967.

2. In view of the above, there shall be a direction to the 3rd respondent to release the vehicle to the petitioner on his paying ₹25,000/- (Rupees Twenty five thousand only). Once the petitioner remits the amount, the 3rd respondent shall release the vehicle to the petitioner forthwith by the respondent. If any crime has been registered against the petitioner, the 3rd respondent shall report the composition of the offence before the competent Court.

The Writ Petition is disposed of as above.
