The petitioner is an Indian national wants to marry a Foreign national. The petitioner given notice on 13.4.2015. Ext.P8 is the notice. In view of the fact that there is no Marriage Officer is appointed in a Foreign Country to which the Foreign national belongs, this Court in several judgments directed that accepting credible documents, the marriage can be solemnized in respect of the Marriage Act. If the petitioner produces the original document relating to the single status of the Foreign national, the marriage shall be solemnised in accordance with the original notice given on 13.4.2015.
