The above writ petition has been filed allegedly on the ground that the petitioner has been threatened by the party respondents, that the measurement as directed in Ext.P1 will not be carried out. The measurement as directed by the Division Bench is to be carried out on 28.04.2015 at 10 am. It is also directed specifically in Ext.P1 that both parties shall co-operate in the measurement of the property.

2. The police shall afford necessary protection for carrying out the measurement as directed in Ext.P1 judgment, if a complaint is made on that respect. It is made clear that

the Police shall not interfere with the measurement at all and shall only ensure that no breach of law and order situation is occasioned and that all the parties are able to be present in the locality when measurement is carried out.
