J U D G M E N T

The petitioner admittedly is the daughter of one Yasodha, who belongs to the Scheduled Caste - Pulaya community. The mother of the petitioner had brought up the petitioner and two other children, born in the wedlock to one Sasi, whose caste is not known and whose whereabouts are also not known. The petitioner, in fact, was brought up by the mother, who belongs to a Scheduled Caste community.

2. In such circumstance, Ext.P8 Government Order would be applicable to the case of the petitioner. The petitioner shall, hence, be considered to be a Scheduled Caste community candidate and necessary certificate shall also be issued.

Writ petition is allowed.
