JUDGMENT

The petitioner, owner of stage carriage No.KL-11X/9404, applied for temporary permit on the route Prakkulam-Chinnakada in the vacancy of stage carriage No.KL 16/5859. The petitioner has approached this Court with a prayer to direct the respondent to grant and issue temporary permit to the petitioner's stage carriage No.KL-11X/9404 on the route Prakkulam-Chinnakada in the vacant timings of stage carriage bearing No.KL 16/5859.

2. If vacancy of stage carriage bearing registration No.KL 16/5859 is still in existence and no other person has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to issue a temporary permit of four months' duration within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P1. Needless to say, such issuance of temporary permit will be subject to the preferential claim of other persons.
