JUDGMENT

The petitioner is an Indian citizen. The petitioner intends to marry American Citizen by name Stephanie Ann Kirstein. The petitioner approached this Court on account of non-acceptance of Ext. P7 application form of Notice of Intended Marriage.

In view of the judgments of this Court, produced as Exts.P9 and P10, there shall be a direction to the Marriage Officer-third respondent to accept the Notice of Intended Marriage reckoning the date of notice as on today, the marriage shall be solemnised in accordance with law on condition that the petitioner produces the certificate from the Consulate General or any other credible certificate to show that Foreign national has no impediment in marrying

the petitioner. The directions in Exts.P9 and P10 judgments also would apply to the petitioner. The petitioner shall also produce Exts.P9 and P10 judgments before the third respondent.

The writ petition is disposed of as above.
