JUDGMENT

The petitioner, the owner of stage carriage bearing No.KL-09-L-4708, applied for temporary permit on the route Padaparamba-Mannen kai in the vacancy of stage carriage No. KL-10-P-126. The petitioner has approached this Court with a prayer to direct the respondent to grant and issue temporary permit to the petitioner's stage carriage No.KL-09-L-4708 on the route Padaparamba-Mannen kai in the vacant timings of stage carriage bearing No.KL-10-P-126.

2. If vacancy of stage carriage bearing registration No. KL-10-P-126 is still in existence and no other person having better claim has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to issue a temporary permit of four months

duration if there is no legal impediment within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P1. Needless to say, such issuance of temporary permit will be subject to the preferential claim if any.

The writ petition is disposed of. No costs.
