JUDGMENT

Petitioner made Ext.P2 request to transfer him to Mavelikkara or nearby stations. Petitioner claims that he is the senior-most 'Santhi' working under the Travancore Devaswom Board.

2. Considering the request of the petitioner as per Ext.P2, if there is vacancy for accommodating the petitioner in Mavelikkara in the general transfer for the year 2015-2016, following norms of transfer, a decision shall be taken by the 1st respondent. If general transfer is not taking place within two months, a decision shall be taken on Ext.P2 within two months.
