JUDGMENT

The petitioner, the owner of stage carriage applied for temporary permit on the route Erattil-Varkala in the vacancy of stage carrier bearing No.KL 16/18. The petitioner has approached this Court with a prayer to direct the respondent to grant and issue temporary permit to the petitioner's stage carriage on the route Erattil-Varkala in the vacant timings of stage carrier bearing No.KL 16/18.

2. If vacancy of stage carriage bearing registration No.KL 16/18 is still in existence and no other person has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to issue a temporary permit of four month's duration within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P1. Needless to say, such issuance of temporary permit will be subject to the preferential claim of other persons.

Writ petition is disposed of as above.
