JUDGMENT

The petitioner, the owner of stage carriage No.17 D/7554 applied for temporary permit on the route Oyoor- Ayoor in the vacancy of stage carriage bearing No.KL 16/1665. The petitioner has approached this Court with a prayer to direct the respondent to grant and issue temporary permit to the petitioner's stage carriage No.17 D/7554 on the route Oyoor-Ayoor in the vacant timings of stage carrier bearing No.KL 16/1665.

2. If vacancy of stage carriage bearing registration No.KL 16/1665 is still in existence and no other person has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the respondent to issue a temporary permit of four month's duration within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P1. Needless to say, such issuance of temporary permit will be subject to the preferential claim of other persons.
