JUDGMENT

The petitioner approached the third respondent by Ext.P2. The petitioner highlights his grievance that the petitioner is entitled for category change to the post of L.D.Clerk. The petitioner has been appointed under dying in harness scheme as a 'Kzhakom'. The petitioner submits that he has sufficient qualification to be appointed as L.D.Clerk. The petitioner submits that he has been appointed as 'Kzhakom' on the reason that there were no vacancy at the relevant point of time in the post of L.D. Clerk. The petitioner also submits that there are sufficient vacancies in the post of L.D.Clerk and she may be considered for the post of L.D.Clerk.

In view of Ext.P2, appropriate decision shall be taken on the same by the third respondent within a period of six weeks after hearing the petitioner.
