J U D G M E N T

The petitioner, who is presently working as Overseer Grade-III in the Kerala Water Authority, is aggrieved by the steps taken by the respondent Water Authority to effect promotion to the post of Overseer Grade-II by ignoring the seniority of the petitioner. Highlighting his grievance, he has preferred Ext.P1 representation before the 1st respondent and the limited prayer in the writ petition is for a direction to the 1st respondent to consider and pass orders on Ext.P1 representation within a time frame.

2. I have heard the learned counsel for the petitioner as also the learned Standing counsel for the respondent Water Authority.

On a consideration of the facts and circumstances of the case as also the submissions made across the bar, I dispose the writ petition with a direction to the 1st respondent to consider and pass orders on Ext.P1 representation within a period of one month from the date of receipt of a copy of this judgment, after hearing the petitioner.
