SHAFFIQUE, J.

The petitioner has approached this Court seeking police protection alleging that there was threat from respondents 3 to 5. It is submitted by the learned counsel for the respondents that the issue between the parties is not with regard to any financial transaction, whereas the dispute is regarding the immovable property mortgaged by the friends and relatives of respondents 3 to 5 and a civil suit is pending between the parties.
