JUDGMENT

The petitioners are teachers appointed as HSA's in different subjects in permanent vacancies sanctioned as per the staff fixation orders in the aided school under the management of the 3rd respondent. Against the orders of the 2nd respondent rejecting approval of their appointments, the petitioners have filed appeals, which are stated to be pending before the 1st respondent. The limited prayer of the petitioners in this writ petition is for a direction to the 1st respondent to consider and pass orders on the appeals within a specified time limit.

2. I have heard the learned counsel appearing for the petitioners and also the learned Government Pleader appearing for the respondents.

On a consideration of the facts and circumstances of the case and the submissions made across the bar, I dispose the writ petition with a direction to the 1st respondent to consider and pass orders on Exts.P5, P13, P14, P15 and P19 appeals filed by the petitioners, within a period of two months from the date of receipt of a copy of this judgment, after hearing the petitioners.
