J U D G M E N T

Petitioners, aggrieved by the orders issued by the Consumer Disputes Redressal Forum, Thrissur, approached this Court. Exts.P4 and P5 and also Exts.P6 and P7 are the orders issued by the Forum.

2. Petitioners' case is that they are not partners of the firm-M/s.Clear Finance engaged in money lending business, which is the respondent before the Consumer Disputes Redressal Forum. Their father was a partner of the above firm and he is no more. He died in the year 2002.

3. This Court is of the view that the petitioners shall raise their objections before the Consumer Disputes Redressal Forum. This shall be done within a period of one month from the date of receipt of a copy of this judgment. Thereafter, the Forum shall pass appropriate

orders after hearing the petitioners. Till a decision is taken by the Forum as above, no coercive steps shall be taken against the petitioners.
