JUDGMENT

The petitioner approached the first respondent by Ext.P7 revision petition under Section 83(2) of the Revenue Recovery Act against the order passed by the Land Revenue Commissioner, Thiruvananthapuram. The only request made before this Court is that an early disposal of Ext.P7 revision petition.

2. The matter is relating to recovery of the loan amount advanced by the State Bank of Travancore. The petitioner availed an educational loan. This Court directed the petitioner to remit Rs.50,000/- within two weeks and the petitioner has remitted the same.

In that view of the matter, there shall be a direction to the first respondent to consider Ext.P7 revision petition after hearing the petitioner and the officials of the Bank within two months. Till disposal of the revision petition, entire revenue recovery proceedings against the petitioner shall be deferred.

The writ petition is disposed of as above.
