J U D G M E N T

The petitioners who have approached this Court aggrieved by the non-release of arrears of pension, seek a direction to the respondents to pay the pensionary benefits that are due and admitted to them within a stipulated time frame. The facts in the writ petition, together with Exts.P1 to P21 statements, would clearly indicate that the amounts that are due to the petitioners, as stated in the said exhibits, have been admitted as due and payable to the petitioners by the respondents. The only difficulty expressed by counsel for the respondents is with regard to the paucity of funds which has prevented the respondents from effecting disbursement of the pensionary payments in a timely manner.

2. I have heard the learned counsel for the petitioner, learned Standing counsel for the Kerala Agricultural University and also the learned Government Pleader.

3. On a consideration of the facts and circumstances of the case, as also the submissions made across the bar, and taking into account the submission of the learned Standing counsel for the

respondent University with regard to the financial hardship faced by the University, I dispose the writ petition with a direction to the respondents 3 and 4 to disburse the pension arrears as evidenced by Exts.P1 to P21 to the petitioners in six equal monthly instalments commencing from 15.06.2015.

The writ petition is disposed as above.
