JUDGMENT

The petitioner confines his relief to easy instalments to pay the dues to the first respondent bank and to defer the coercive steps in the meanwhile.

2. I permit the petitioner to remit one fourth of the dues outstanding within one month from today. The balance amount shall be deposited in eight equal monthly instalments starting from 30.09.2015.

3. The coercive steps pursuant to Ext.P2 notice shall be put on hold if the petitioner complies with the conditions in time. The coercive steps shall surge ahead if the petitioner commits default in the payment of any one of the instalments as directed.

The Writ Petition is disposed of.
