JUDGMENT

The petitioner seeks category change on medical grounds. Exts. P3, P4 applications and Ext. P7 representation pertain to the same. The petitioner contends that he has acquired physical disability. Category change is sought since posting on light duty was declined. The petitioner is also aggrieved by the present transfer and posting at Alappuzha depot.

2. I direct the second respondent to consider Ext. P7 representation with notice to the petitioner. The needful shall be done within a period of one month from the date of production of a copy of this judgment. Appropriate posting on the basis of category change, if any, shall also be given to the petitioner.

The writ petition is disposed of.
