J U D G M E N T

It is reported that the election to the Managing Committee of the second respondent Bank has already been notified to take place on 12.7.2015. The petitioners however express apprehension about the validity of the voters list prepared on the basis of which the election is to be conducted.

2. The election calendar shows that preliminary voters list would be published on 8.6.2015 to which objections could be filed by any person aggrieved on or before 15.6.2015. The objections to the voters list would be considered on 16.6.2015 and final voters list would be published at 11 am on 17.6.2015.

3. I make it clear that all objections raised as regards the inclusion or non-inclusion of voters in the voters list shall be considered strictly in accordance with law. The question whether the voters list has been prepared in accordance with Rule 18A of the Kerala Co-operative Societies Rules shall be borne in mind.

4. Every endeavour shall be made to hold the election on the date notified without adjourning the same at any cost.

The writ Petition is disposed of.
