J U D G M E N T

The petitioner was aggrieved with the administrative sanction not being granted to the work entrusted to the petitioner and carried out successfully.

2. The learned Government Pleader has produced Annexure R5(a) which indicates that administrative sanction has been granted on 24.06.2015. The delay was due to the fact that there was enquiry going on with respect to the work.

3. Now, in any event, since administrative sanction has been obtained and it has been stated that the payment would be considered as expeditiously as possible, the same shall be done, taking up the bills first sanctioned for payment first. It is directed that the payments to the

petitioner will be effected as per the seniority system followed by the Government as expeditiously as possible.
