J U D G M E N T

The petitioner, who is presently working as an Upper Primary School Assistant in TTTM Vocational Higher Secondary School, Vadasserikkara, is aggrieved by the limits imposed while approving the appointment order issued to her. In the writ petition, it is stated that against Ext.P10 approval order, the petitioner has preferred Ext.P16 revision before the 2nd respondent and the prayer in the writ petition is for a direction to the 2nd respondent to consider and pass orders on Ext.P16 revision, after hearing the petitioner.

2. I have heard the learned counsel for the petitioner as also the learned Government pleader for the respondents.

On a consideration of the facts and circumstances of the case, as also the submissions made across the bar, I dispose the writ petition with a direction to the 2nd respondent to consider and pass orders on Ext.P16 revision, after hearing the petitioner, within a period of two

months from the date of receipt of a copy of this judgment. While passing orders as directed above, the 2nd respondent shall also take note of Exts.P11 to P15 Government Orders.
