J U D G M E N T

The petitioner who has been working as HSST (Malayalam) (Jr.) against a vacancy with effect from 30.12.2013 onwards has preferred Ext.P9 representation before the 1st respondent seeking a direction to the 2nd respondent to approve his appointment and disburse salary arrears to him. The limited prayer of the petitioner in the writ petition is for a direction to the 1st respondent to consider and pass orders on Ext.P9 representation.

2. I have heard the learned counsel for the petitioner and the learned Government Pleader for the respondents.

On a consideration of the facts and circumstances of the case, as also the submissions made across the bar, I dispose the writ petition with a direction to the 1st respondent to consider and pass orders on Ext.P9 representation, after hearing the petitioner, within a period of one month from the date of receipt of a copy of this judgment.
