JUDGMENT

In connection with appointments, that were made to the post of UPSA by the petitioners, against retirement/promotion vacancies, the petitioners had forwarded the appointment letters to the 2nd respondent for approval. It is the case of the petitioners that, notwithstanding the forwarding of the letters of appointment to the 2nd respondent, the 2nd respondent has not passed any orders in the matter till date. It is under these circumstances, that the petitioners have approached this Court through the present writ petitions.
