The petitioner, an existing Akshaya E-Centre holder, is apprehensive that the notification now published for granting another Akshaya E-Centre would be established within 2 Kms of his centre thus violating the fundamental rule of such allotment.

2. The learned Government Pleader submits that even if such an Akshaya E-Centre is granted it would be only in accordance with the Rules and the same would be situated only 2 Kms away from the petitioner's unit.

Writ Petition is disposed of accordingly.
