2. Petitioner has come up in this writ petition seeking police protection. Allegations have been made against respondents 3 to 5, who are close relatives of the petitioner. From the allegations made in the writ petition, it is clear that the dispute between the parties is more or less a family dispute. Allegation of the petitioner is that the respondents are putting pressure on the petitioner to transfer his properties. Petitioner being a major person, we see no reason to believe such allegation.
