J U D G M E N T

The petitioner claims to be one of the legal heirs of the owner of the property which was acquired for Metro Rail Project. There is a rival claim for the compensation amount by the children of the deceased siblings of the petitioner. The matter is engaging the attention of the second respondent before whom Ext.P5 representation is pending.

2. I direct the second respondent to consider Ext.P5 representation with notice to the petitioner and respondents 3 to 11. Needful shall be done within a period of one month from the date of receipt of a copy of this judgment. The disbursement of the compensation amount will abide by the orders to be passed on Ext.P5 representation as directed above.
