JUDGMENT

The petitioner approached this Court on account of non-payment of remuneration for the period from 27.6.2012 to 31.3.2013. The petitioner submits that he was appointed as 'Hindi Teacher' in the 4th respondent school on daily wages during the above period. According to the petitioner, he has not paid any remuneration for the above period. Accordingly, the petitioner has approached this Court.

2. The learned Government Pleader, on instructions, submits that the proposal of the Manager has been returned pointing out certain defects.

In view of the above, the Manager shall re-submit the proposal after curing the defects within a period of four weeks from the date of receipt of a copy of this judgment.

Thereupon, appropriate decision shall be taken by the third respondent within a further period of six weeks. However, if it is found that the petitioner is entitled for daily wages during the above period, the same shall be disbursed within a period of three months.

The writ petition is disposed of as above.
