The petitioner seeks correction of data bank with respect to a property having an extent of 63 cents comprised in Sy.No.209/1 in Block 83 of Mambad Village, Nilambur Taluk covered by registered document No.4557/2013 of Nilambur SRO.

2. The learned Special Government Pleader (Revenue) submits on instructions that already the property is described as land converted 10 years back in the data bank. In such circumstance, the petitioner would have to approach the appropriate authority under the Kerala Land Utilization Order 1967 as has been declared in **Puthan Purakkal Joseph v.
