JUDGMENT

The petitioner's school also allotted an additional batch and 5 posts were sanctioned in HSST (Junior) and one post for upgradation. The petitioner points out that there is some anomaly in sanctioning the posts and submits that they are entitled for four more posts in HSST (Junior). The petitioner submits that the anomaly has been considered by Ext.P4 dated 11.10.2013 by the Director of Higher Secondary Education and decided to recommend to the Government. However, no action has been taken by the Government. Accordingly, the petitioner has approached this Court.

In view of the fact that the anomalies pointed out in respect of the school has not been considered by the Government, there shall be a direction to the Government to

take appropriate decision in the matter in relation to the petitioner's School after affording an opportunity of hearing to the petitioner within a period of six weeks from the date of receipt of a copy of this judgment.

The writ petition is disposed of as above.
