JUDGMENT

Penalty has been imposed for alleged non-segregation of light load and power load in the industrial premises of the petitioner. The petitioner has taken up the issue with the grievance redressal for in terms of Clause 130 Sub Clause 8 of the Kerala Electricity Supply Code, 2014. The petitioner apprehends disconnection of electricity supply for not paying the penalty demanded.

2. I direct the fourth respondent to dispose of Ext.P7 complaint within a period of three months. The needful shall be done with notice to petitioner and affected parties.

3. The coercive steps pursuant to Ext.P6 order of the second respondent shall be put on hold in the meanwhile. This is subject to the condition that the petitioner remits one third of the amount demanded thereunder within a period of one month.

The Writ Petition is disposed of.
