JUDGMENT

All that the petitioner wants is to implement the orders as regards the shifting of the electricity post located behind his shop room bearing No. IX/2884 of Munnar Grama Panchayat. The petitioner contends that Exts.P7 and P8 orders govern the field and that they have not been challenged by anybody.

2. I direct respondents 5 and 6 to take steps for shifting the electricity post in accordance with the orders in existence. The needful shall be done within a period of two weeks on collecting the requisite labour charges from the petitioner.
